## Traffic Calming Program Petition to be Circulated

Earlier this summer, Lafayette Village Community Association received the good news that our community's main street, Lafayette Village Drive, qualified for inclusion in the County's Traffic Calming program. (See the article in the July/August Newsletter.) If we meet certain conditions, this program will allow LVCA to develop a community-based traffic-calming plan for Lafayette Village Drive that will address such issues as the fact that almost 300 vehicles a day drive down Lafayette Village exceeding the speed limit by more than 50%.

To make this happen, 75% of the neighborhood's residents must sign a petition agreeing to the creation of a community-based traffic calming task force. It is this task force that will develop the community-based plan to calm the traffic on Lafayette Village Drive. In the next month, you will be contacted by one of your neighbors who have volunteered to carry the petition door-to-door. Please sign the petition so that we can proceed with the Traffic Calming program.

#### **Trash and Recycling News**

LVCA just awarded a 3-year contract to American Disposal Services for trash collection and recycling. The cost of the contract was \$22.74 per month for single family homes on Merrimac Trail and \$15.95 per month for the townhomes. This price will result in about a \$10,000 per year increase in the cost of waste disposal. However, this was the best price that could be found for twice per week collection of trash and once per week recycling.

Our trash collection days remain the same – Monday and Thursday. Recycling is collected only on Thursday. Trash should be placed in front of your home by 6:00 a.m. or no earlier than dark the previous day. Trash should be stored in trash cans, but can be temporarily placed in plastic bags for collection. Recyclables should be placed in the bin provided or in clear plastic bags so the workers can distinguish recycling materials from trash.

Since we're paying for the service, we should use it by participating in the recycling program. Glass bottles and jars, aluminum cans, plastic bottles, metal food and beverage cans, mixed paper, flattened cardboard and newspaper can be recycled. By recycling we help save on the cost of actual disposal of trash. Please participate.

If you have small amounts of yard waste and brush, you can add it to the trash collection. If you have bulky items, you may need to call American Disposal for a special collection. Sometimes there can be a charge for very large items such as refrigerators or stoves. The service number for American Disposal Services is 703-368-0500.

Trash service is provided every Monday and Thursday except when those days are Thanksgiving, Christmas Day or New Years Day. Service will be on the next regular collection day following the holiday.

If you suspect a missed collection at your home, try to call before 2:00 p.m. and often the company can correct the mistake that day or at least advise you about collecting the next day. Please let Board members know if you have concerns about the trash collection, so they can alert American Disposal to our customer complaints.

## **NEIGHBORHOOD WATCH**




The Neighborhood Watch encourages total community involvement in discouraging preventable crime by organizing and providing technical assistance through awareness meetings that help neighbors get to know one another, learn to secure their property, look out for one another, and recognize and report suspicious activity. It encourages community and individual involvement in crime prevention and targets burglaries, larcenies, and vandalism in residential areas.

We are asking everyone to pay attention to happenings in the community and report unusual occurrences. Our first awareness meeting will be soon and we would like as many residents as possible to participate. We are not asking anyone to endanger him or herself in any way. Our program will involve volunteering one day per month (the same day each month) to patrol the neighborhood either riding or walking. The increase in homeowner awareness of what is "normal" in the neighborhood is a key benefit of the program. Watch members then automatically will scan the community streets as they go about their daily life in LVCA and will have a feel for unusual behavior or circumstances that should be reported to the police.

#### Tree Report

The Architectural Control Committee (ACC) has proposed a substantially larger budget for 2007 than was approved for 2006. The purpose is to increase tree and shrub management efforts throughout the community. In 2006, many residents have requested tree trimming, removal, and replacements which simply could not be accomplished because of lack of funding. The ACC wishes to thank Hattie and Vern Walden for donating 2 Crape Myrtle trees to the community. The trees will be planted by the basketball court, where several dead or diseased pine trees were removed earlier this year. The small ACC budget approved for 2006 could not afford replacing them. The Walden's are congratulated for their outstanding citizenship. Lafayette Village is fortunate the Walden's are members of our community.

Another member of our community has indicated she is willing to donate and plant a tree in Lafayette Village, to replace dead or diseased trees that were removed. Details about what tree will be donated and where it will be planted are forthcoming. Look forward to learning more about this generous citizen in our next newsletter.

As all of you who have been reading our newsletters know, the ACC budget for tree and shrub management in 2006 was exhausted very early in the year. If you believe the Association should do more for tree and shrub trimming, removal, and replacement throughout the community, please support the ACC budget request for 2007. ## FINANCE COMMITTEE

#### Committee Reports continued

The financial situation in LVCA remains about the same as the last newsletter. Income remains slightly below what was projected in the budget due to unpaid quarterly assessments. The expenditures in the budget are exceeding the budget due to unplanned repairs needed at the pool, a new trash and recycling contract, additional unbudgeted tree removal and stump grinding, and other miscellaneous administrative costs.

The Finance Committee has drafted a 2007 budget with input from the ACC, pool, neighborhood watch, recreation, and communication committees. The draft budget was discussed at the September 11 Board of Directors' meeting and a copy is attached to the newsletter. The Finance Committee is recommending a 10% increase in quarterly assessments: single-family homes on Merrimac Trail would pay \$139 and townhomes \$272 per quarter.

Homeowners will be able to ask questions and discuss the draft 2007 budget at the October 9 (LVCA Annual Meeting) Board of Directors meeting. Let the Board hear what your priorities are for funding the budget. The Board will approve the budget and determine the actual annual assessments after that discussion.

If all the committee requests are approved, there will be **no** money going into the reserve fund in 2007. There is not enough income to pay for all the items that need to be done in 2007. Regrettably unless spending is reduced, sometime in the future, LVCA will need to raise additional funds through means other than quarterly assessments.

Please volunteer and join the Finance Committee if you have thoughts/experience in improved budgeting practices or methods to use improve our financial situation.

## Highlights of the Budget

**ACC** requests funds for additional erosion control projects, tree management plan (trimming or removal of trees, replacement of trees), mailboxes, and 3 security lights.

**Pool** requests includes replacement of bathhouse sinks, replacement of the privacy fences, a new lifeguard chair and (if approved) replacement of the pool deck.

Trash contract increases over \$10,000 per year

**Grounds contract** expires and the expected increase for the new contract is \$8-10,000 per year

## **Board meets with Management of Hidden Oaks Nature Center**

Once of the wonderful amenities Lafayette Village residents share is our close proximity to the Hidden Oaks Nature Center and the Annandale Community Park. The beauty of the park, its trails and nature center and its recreational facilities all contribute to the attractiveness of our community. Recently, however, the park has become a source of some concern to our residents. Invasive plants are killing trees on Lafayette Village Drive and encroaching on community property. There have been reports of people living in the park behind our homes. And parts of the park are inaccessible and almost unusable.

In July, the LVCA Board of Directors met with the managers of Hidden Oaks Nature Center and other Fairfax County Parks Authority staff to discuss these and other issues. We agreed that in general the park has been a great resource for our community that enhances the quality of life in Lafayette Village. We are happy to be neighbors with the park.

Invasive Plants: Invasive vines and plants are a huge problem throughout Fairfax County. Park management does not have the funds to remove invasive plants. Also, the Board learned that the Park and parts of Lafayette Village are designated as a "Resource Protection Area" which limits how these invasives can be controlled. However, if residents volunteered, Park staff will train these volunteers in developing an "Invasive Management Area" plan to remove these undesirable plants and replant removal areas with native plants. If you would like to volunteer for this project, please contact Board Member Carl Iddings. The park manager also agreed to survey our common border. Once the survey is completed, Springfield Nursery, our grounds maintenance contractor, will be directed to remove all invasives encroaching on LVCA property.

**Homelessness in Park:** After thorough investigation both by Board members and by Park staff, it was determined that there was no evidence of any recent homeless activity in the southwest area of the park abutting the 495 culvert. Park staff will continue to monitor that area.

Increase accessibility to the Southwest part of Annandale Community Park: The Board and Park staff noted that many of the trails in the southwest part of the park are soggy and poorly connected to the rest of the park. The Park management agreed to investigate installing a footbridge across the creek to improve access to the rest of the park. In addition, if volunteers can be found, the Park will supply wood chips to be laid down on the paths in that area of the park. For particularly wet trails, the Park will consider placing duck boards on the paths. If you would like to volunteer for this project, please contact Board Member Carl Iddings.

#### FALL TIPS FOR THE GARDENER

- Fall is a great time to plant trees, shrubs, bulbs, perennials, grass seed and sod. Plants that are planted in the fall enjoy cooler temperatures and ideal growing conditions that allow roots ample time to grow into the surrounding soil. Be sure to use Starter Plant Food at the time of planting.
- Plants and trees that provide color in the month of October include burning bush, camellia, ornamental cabbage and kale, pansies viburnum, crape myrtles, October Glory maple, red sunset maple, nandina, pyracantha, sweet gum and Virginia creeper.
- There are lots of perennials with interest now including anemone, chrysanthemums, perennial asters and ornamental grasses.
- Plant spring blooming fall bulbs <u>now</u>. Plant iris, tulips, crocus, daffodils and many others for glorious spring color.
- Add a touch of fall to your home and landscape with hardy mums.
- Do not prune azaleas, rhododendrons and other spring flowering shrubs because they have already set their buds for next year's blooms. If you feel these shrubs do need to be pruned, however, you can prune them now, but you will sacrifice next spring flowers.
- Time to feed your plants with a good quality slow release plant food. It is recommended to fertilize perennials and flowering shrubs and trees with flowering plant food. A blended plant food contains slow-release nitrogen, sulfate of potash, iron and other micro-nutrients for overall plant growth and development.
- It is recommended feeding evergreens (hollies, boxwoods and yews) and deciduous trees (maples, oaks and ash) with tree & shrub food. A product should contain slow-release nitrogen, sulfate of potash, iron and other micro-nutrients for overall plant growth and development.

- Time to dig gladiolus. Remove the tops and let them dry for two weeks. Dust them with Sulfur. Store in dry peat moss or vermiculite at room temperature. Time to transplant peonies or divide them if you wish to multiply your plants.
- October is a great time to lime seed and fertilize your lawn. You can seed a new lawn in early October or reseed (overseed) an established lawn this month to make it thicker and healthier.
- If you need to, you can lime, fertilize and seed your lawn all in the same day. Otherwise, seed and fertilize the same day and then lime later in the fall.
- If needed, fall is a great time to aerate and/or dethatch the lawn. If you decide to do one or both of these, they should be done prior to seeding.
- If you do plan to aerate, dethatch or rototill (for total renovation), thoroughly soak the soil a day or two before you start your project or perform your project a day or two after a good rain.
- Now is also a good time to control weeds growing in the lawn, however you cannot weed kill and seed the same day.
- If you choose to kill weeds in the lawn first, you must
  wait three weeks to seed your lawn. Or, if you seed first,
  you will need to wait until the new seed has germinated
  and been mowed at least twice before applying a weed
  killer
- If you want to prevent winter annual weeds from germinating in the lawn, you can apply Portrait in early October, but this would prevent you from seeding now. You will have to wait 60 days to seed, which means you would probably need to wait until spring to seed the lawn.

## PAVING AND SEALING STREET WORK TO BE DONE SEPTEMBER 27 THROUGH OCTOBER 6

In order to maintain our streets and extend their useful life, the LVCA Board has contracted with Pro-Pave, Inc. to make street repairs and to seal coat our streets. This work will start September 27<sup>th</sup> and continue through October 6<sup>th</sup>, weather permitting. Pro-Pave will patch the most deteriorated parts of our streets, removing the old asphalt and replacing it with a new layer of asphalt. Once repair work is done, all neighborhood streets will have cracks filled and the entire street sealed with a protective coating that will extend the life of the pavement. This work will help ensure that our streets last at least the next six years until 2012 when our streets are scheduled to be resurfaced.

#### Patching our streets:

Most neighborhood streets will have some patch work performed, but the bulk of the work will be performed on Yorktown Village Pass, Trammell Court, and Butterfield Lane/Mt. Airey Lane. Patch work will start on Wednesday, September 27<sup>th</sup> and continue through Friday, September 29<sup>th</sup>. The following streets will be patched during this time:

Hampton Village Pass
Ashley Glen Road
Butterfield Lane
Mt. Airey Lane
Byrds Nest Pass
Yorktown Village Pass
Trammell Court
Colonial Village Pass
Peyton Forest Trail
Brunswick Forest Trail

The areas to be patched on each street will be clearly marked with orange paint before the 27th, and residents will be notified a day in advance when patch work is to be done. Streets will **not** be closed during this work. If you need to drive on a street being patched, Pro-Pave workers will direct you safely around the patching work. If your car is parked near an area to be patched, you will want to move it before 7:00am on the day the work is to be done or risk having your car towed or damaged. Pro-Pave recommends that newly patched areas be kept free of traffic for at least 24 hours. We appreciate your cooperation with this request.

#### Crack-filling and Seal coating:

**All** community streets will be crack-filled and seal coated starting Monday, October 2<sup>nd</sup>. This work has two parts: first, cracks will be cleaned of grass, dirt and debris and then filled with an asphalt-type rubberized crack sealer. Once the cracks have been filled, an asphalt resin-based coating will be applied to the street surface to protect it against environmental damage and to prevent the asphalt street from raveling and cracking. The coating used will be SealMaster Master Seal, and once applied, must be kept free of traffic

for at least 24 hours to ensure it properly bonds with the asphalt.

Pro-Pave cannot seal our streets when it rains. In case of rain, the sealcoat work will be moved back to the next dry business day, and the schedule will be adjusted accordingly. For example, if it rains on Tuesday October 3<sup>rd</sup>, the work originally scheduled for Butterfield Lane on this day will move to Wednesday. Then, the entire schedule moves back one day in this scenario, with the final day of work moving to October 9<sup>th</sup>.

The crack-filling and sealcoat work will require that all cars on the street being sealed must be moved by 7:00am on the day the work is to be done. **CARS THAT HAVE NOT BEEN MOVED BY 7:00AM WILL BE TOWED AT THE OWNER'S EXPENSE.** Once the seal coat is applied, the street will be closed to traffic until the afternoon of the day following the seal-coating. Residents will be notified at least a day in advance when their street is scheduled to be sealed.
