#### RESPECT OUR COMMUNITY

There have been several reports of illegal and unneighborly-like conduct. It is **illegal** to dump motor oil into the ground, storm drains or in your trash. Chemicals, like motor oil, will seep into the water table which could end up in our water supply. It also can kill animals and vegetation. Dumping one gallon of oil can contaminate one million gallons of water. Dumping motor oil is even more hazardous than the ocean oil spills we often hear about because it is not crude oil, it is *refined* oil, which has been processed to serve a different purpose. Used motor oil has heavy metals and harmful ingredients and also contains metal worn away from the engine and other dangerous materials.

You must take the oil to a local recycling center. If you see anyone dumping oil or other toxic chemicals directly into the ground, please notify KPA immediately by phone or email. Be prepared to provide a description (house address, car make/model and license, physical description etc.) See page 7 for more information on a special waste disposal day coming up in Annandale!

Visitor parking is available for **temporary** visitors. It is not for multiple resident renters. Each house (without a garage) is provided two spaces.

Please do not litter. Several months ago many members of our community collected several bags of trash. Already, litter is rearing its ugly head around the neighborhood. We've had a lot of windy days, so always make sure your trash is secure.

Your trash cans, recycling bins, toys and more should not be stored in your front yards. *Thank you for being a good neighbor!*

#### **Report Suspicious Activity!**

#### Call the Police Non-Emergency Number (703-691-2131)

Use the non-emergency number to call to let the police know of any suspicious activity, to report crimes that have already occurred or when the suspect is no longer in the area. The non-emergency number is open 24 hours and is used for police, fire and rescue non-emergency reports. You will be asked for your name, address, telephone number. This information is requested in case additional contact with you is needed. You do not need to provide this information if you do not want to. **Any information provided to the police is confidential.** 

Call 911 for crimes in progress and events which are life-threatening.

After you have called the police please report the incident or suspicious activity to the Neighborhood Watch Committee.

## Grounds Committee Update ...

#### Common Grounds..... for Common Enjoyment

The Grounds Committee and several community residents have been working hard to give our aging community a face lift and to enhance and beautify our surroundings. As you walk or drive through the community, you will notice that dead trees have been removed, other trees pruned, and new trees planted! Thanks to the generosity of one resident, two new crepe myrtles were planted on Butterfield. On Peyton Forest, a group of residents put in brick edging and a flower bed on a portion of common area. Two erosion projects have been completed with more scheduled for the future. Invasive bamboo has been cut down behind Byrds Nest Pass with clean up still in the works. Volunteers welcome!!!

If you or a group of your neighbors have an idea/suggestion for a common area, or a special project you would like to undertake, please contact a member of the Grounds Committee or a Board member for prior approval. Several sitting benches will be purchased for the community and if you have a project idea for a sitting area, please let the Grounds Committee know. Remember, per LVCA Guidelines, no alterations may be made to common areas without prior approval, but resident input is encouraged and welcomed.

Another way we can all help to beautify our community, without any cost or sweat equity involved, is to remember to throw your trash away in your home trash receptacles. It is not appropriate to dump your household trash in the community trash cans. PLEASE, though, if the community trash receptacle is full, do not leave any trash on the side, or loose on top. Cool breezes, gusts of wind, and our neighborhood friends, the squirrels and birds, send the trash scattering.

Additionally, if you are landscaping or putting up a new fence, please be aware of where your property line is in relation to common ground/LVCA property. Those homeowners who have extended their fences beyond their property lines will receive notice to correct the problem.

Since we are working hard to beautify our surroundings, let's remember that dumping is NOT permitted on common grounds including LVCA property. This includes the dumping of yard debris, trimmings, and the like. Please remind any contractors doing work for you that they need to bag up their debris and remove it, or if part of your agreement, leave it for scheduled trash removal. The woods surrounding many of our homes is not to be used as a dumping grounds!!! Remember, what may be out of YOUR sight is not out of sight of your neighbor!

#### Would you like a Garden Plot? LVCA Grounds Committee Report

The Grounds Committee is interested in how many residents would take advantage of garden plots next summer in the area under the power lines behind the pool house. We had one homeowner who did a test garden plot for this year and it appears to very successful. If we get enough interest, the area would be tilled and leaf mulch would be added. Water would be available as the area is close to the pool house. ## Community Updates and Recap...

#### **Grounds Committee**

- \* At the last meeting the Committee decided on replacement trees for those that fell during storms this year. A Red Bud tree will be placed in the circle at Butterfield, a Cedar tree in the area next to Hancock Forest and Hampton Village, and an Oak tree & a Serviceberry tree at the end of Brunswick Forest where a Pine and Apple tree fell. The trees will be planted this fall and residents of each street will be asked to come out and help plant them. The exact time and date will be published in the next newsletter.
- \* Our monthly Grounds Workdays have been changed to the second Sunday of each month from 4 to 6pm. In August we will meet on Hampton Village to move paver stone from where the old mail boxes were located to new areas in the community. We'll have other projects as well, so please join us.
- \* Our Grounds Management Company recently did a soil testing of our community and found the levels were within the normal range.
- \* The committee is discussing options on dealing with abuse of the community trash containers placed along the walk ways. Some residents have been dumping their household trash in the containers. This is against LVCA rules and causes the containers to overflow on the ground and makes for a very unsightly mess. The Board has been asked to vigorously enforce the rule and fine violators.
- \* Planning for next years work and the budget are under way. The first draft of the Grounds budget was completed at the July Grounds Committee Meeting. The final recommended budget will be sent to the Finance Committee in September.

#### **Architectural Control Committee (ACC)**

Lafayette Village is an association driven community. There have been several concerns brought to the attention of the ACC, so please continue reading for more information on what you can expect regarding the operation of the committee, the role of the committee and the Management Company, and clarification on your role, as a homeowner.

Several concerns have been brought to the attention of the Architectural Control Committee (ACC) from homeowners that were cited for violations, and homeowners that have reported violations.

The role of the (ACC) is to ensure that homeowners adhere to ACC Guidelines, maintain their property in accordance with the ACC guidelines and the Lafayette Village Community by-laws. Maintaining LVC property value is extremely important to all of us.

The ACC role is to enforce these rules. Please understand that it is not a "personal" attack when a citation is issued. Our spring inspection fell short in identifying "all" violations. KPA, at the time, was new to our community. Our previous management company failed us in this area also. The ACC is working diligently with KPA to be consistent in identifying violations, notifying the homeowner in a timely manner and conducting follow-up inspections.

Following are steps **YOU** should take when you receive a citation:

- \* Respond in writing to our management company, KPA, immediately acknowledging the violation cited; inform them when the violation will be corrected. Time allowance is in place for major repair, i.e. siding, roof, fences, etc. However, you must request an extension in writing outlining a reasonable timeline for the repairs.
- \* If you are not in agreement with the citation, contact KPA in writing immediately protesting the violation. Further steps will be taken to investigate your claim. Please **do not** ignore citations. The ACC is available to listen to your concerns. Please keep in mind that sending an email or a letter is a better form of documentation than a voicemail or message. Keep a copy for your own records.

#### What's New on the Website?



## Community News...

Perspectives from Penny - Foreclosure is not a four-letter word, but it seems to have some of the same implications these days as the impacts of foreclosure continue to grow. Driven by subprime mortgages and speculative activity, the impacts of foreclosure activity are widespread. From a local government perspective, the loss of property tax revenues has a severe effect on the budget for schools, public safety, human services, and public works projects. Foreclosed properties often remain vacant for long periods, and can fall into disrepair which, in turn, may attract vermin or criminal activity, creating valid concerns for the neighborhood. Foreclosure damages the owner's credit rating and also hurts the mortgage lender and servicer who cannot collect the valid debts owed to them. Economic and emotional disruptions bring unanticipated consequences, too - job loss, breakup of families who still need housing, children who become rootless when moving from school to school.

Despite the gloomy news, the Washington metropolitan region's economy is fundamentally strong and is more resilient because of our position as the nation's capital. High wage jobs, especially in business and professional services, are still being added, although job growth overall is more moderate now. In Mason District, by the end of May 2008, there were 191 foreclosures, spread throughout the district, which had not been resold by the lender. There are about 40,000 residential units in Mason District, so the percentage of foreclosures is extremely small. If you, or someone you know, are facing foreclosure issues, housing counselors may be helpful. The Board Corner: Perspectives from Penny - For all those times you noticed someone parking in an accessible parking space reserved for the disabled without a hanging placard or license plate with a wheelchair symbol, and hoped a ticket could be issued, this violation just got more expensive! During the July 21 Board of Supervisors meeting, the Board approved an increase to the fine for parking in an accessible space reserved for disabled drivers. The previous fine was \$250; effective Tuesday, July 22, 2008, the fine doubles to \$500. Nearly 600 citations were issued in Fairfax County last year to drivers who parked in accessible spaces without the proper documentation. Perhaps the new fine will deter violators and keep accessible parking available for those with legitimate health or disability conditions. Coincidentally, this action was approved just days before the 18th anniversary of the Americans with Disabilities Act (ADA), which was signed into law on July 26, 1990. ADA is comprehensive civil rights legislation at the federal level that protects the rights of people with disabilities.

## HOT Lanes Update...

#### **HOT Lanes Construction Begins**

Construction activities for the Beltway HOT Lanes project has started. In a news release distributed to some Lafayette Village residents, VDOT announced that beginning the week of July 28<sup>th</sup>, there would be partial lane closures on the Beltway at Little River Turnpike in preparation for construction. At the same time, construction would begin on a staging area between Little River Turnpike and Gallows Road on the south-bound Beltway opposite Lafayette Village.

We can expect some construction activity on our portion of the Beltway to begin in August. VDOT will start erecting the partial sound barrier during this initial construction phase. This sound barrier will extend from before the Little River Turnpike north-bound exit to the Beltway (by the service road) to a point opposite the townhomes on Peyton Forest Trail. At this time, there will be no other sound barriers erected adjacent to Lafayette Village – the sound barrier restarts at a point opposite Thor Drive, past the last houses on Trammell Court. VDOT has said that the partial sound barriers will be complete before actually HOT Lanes construction starts.

#### **VDOT Outlines Construction Plans:**

At a meeting on July 8<sup>th</sup>, attended by about 50 people including many Lafayette Village residents, VDOT outlined the HOT Lane construction phases. The first phase would include the start of construction on the replacement Little River Turnpike bridge over the Beltway and the building of sound barriers, including the partial sound barrier for Lafayette Village. The second phase would complete the new bridge, while the third phase removes the old bridge. These three phases will take about three years to complete. While the bridge is being reconstructed, additional Beltway Lanes will be constructed, two on each side of the Beltway. These lanes will be constructed within the existing VDOT right-of-way. Once the bridge is completed in 2011, construction of the actual HOT Lanes will begin. #### **VDOT Responds to Lafayette Village concerns:**

VDOT did respond to the many letters our community submitted in response to the HOT Lanes public hearing and other events residents responded to. VDOT's detailed response is on the website at <a href="https://www.lafayettevillage.org/HOTLanes/VDOT\_Detailed\_Response.pdf">www.lafayettevillage.org/HOTLanes/VDOT\_Detailed\_Response.pdf</a>. VDOT remained unswayed by our arguments, instead responding that the "hill" provided a natural sound barrier, and the proposed sound barrier in conjunction with the "hill" gave Lafayette Village an appropriate level of Beltway noise reduction. The Lafayette Village Board of Directors is still considering how best to respond to VDOT's rejection of our arguments.
