

LAFAYETTE VILLAGE COMMUNITY ASSOCIATION Pool Picnic Pad Agreement

I, _____, a resident of Lafayette Village, wish to reserve the LVCA Pool Picnic Pad on _____ between the hours of _____ and _____. (Note that your party must end 30 minutes before pool closing to ensure you can clean up after your party).

I understand and agree to the following terms and conditions:

1. I have reviewed the current year's LVCA Pool Rules and Regulations and the Pool Picnic Pad Rules, attached to this agreement, and will ensure I and my guests will abide by these rules while in the pool area. These Rules and Regulations have been attached to this agreement.
2. I understand that the pool picnic pad exit gate will only be used by me (or my guests) to bring in supplies for my party and to remove said supplies during clean up. Specifically, I will notify the pool lifeguards when I need to open and close the pool picnic pad gate. In addition, I will ensure that all guests, except those helping me set up for the party, enter the pool through the pool house, and will display to the lifeguards their pool passes or party bands when requested.
3. Wristbands will be provided for up to 10 guests. Valid Lafayette Village pool passes are required for additional guests. All guests, including children over age 3, whether they are swimming or not, must have either a wristband or valid pool pass.
4. I understand that other pool patrons may use the pool picnic pad for food consumption during the hours of my party and agree to leave one table free for the use of those pool patrons.
5. I understand that no food or drink may leave the pool picnic pad area during my party.
6. I understand that the pool closes at 8:30 pm on weekdays and 8:00 pm on weekends and holidays. I agree to clean up the pool picnic pad starting no later than 30 minutes before pool closing. I will be liable for any overtime charges incurred if the pool lifeguards or other pool staff need to remain in the pool after closing to accommodate my clean-up. As part of my clean-up, all trash and recyclables must be removed from the pool premises.
7. I agree that I and my guests will follow all directives issued by the pool life guards, in particular regarding the closing of the pool in the event of rain, thunder and lightning.
8. I, the undersigned resident, understand and agree that neither the LVCA Pool Committee nor the Lafayette Village Community Association is responsible for any actions of me or the guests at my party. I THEREFORE AGREE TO HOLD HARMLESS THE POOL COMMITTEE, THE POOL LIFEGUARDS AND THEIR MANAGEMENT COMPANY, AND LAFAYETTE VILLAGE COMMUNITY ASSOCIATION AND ITS OFFICERS, DIRECTORS AND AGENTS, FROM ANY CLAIMS FOR LIABILITY, DAMAGE, OR LOSS THAT OCCUR IN CONNECTION WITH USE OF THE POOL PICNIC PAD BY ME OR ANY OF MY GUESTS.
